CONDENSED MINUTES MONTHLY BOARD MEETING MARCH 16, 2018

Fort Edward, New York, Friday, March 16, 2018.

The Board of Supervisors convened in regular session at 10:00 AM at the County Office Building, Fort Edward, New York pursuant to Rule 1 of Rules of said Board.

CHAIRMAN HENKE called the meeting to order and presided.

CHAIRMAN HENKE offered the prayer.

Mr. O'Brien led the Pledge of Allegiance to the Flag and read the Fire Safety Notice.

The Clerk read the communications.

CHAIRMAN HENKE announced a proclamation issued recognizing National Crime Victims' Rights Week April 8 – 14, 2018. CHAIRMAN HENKE recommended Supervisors attend the Crime Victims' breakfast ceremony on April 9th.

Mr. Shaw stated that since this came out of committee, there has been a lot of questions and concerns and recommends tabling this resolution to allow more discussion in committee. A motion to table Resolution No. 75, moved by Mr. Shaw, seconded by Supervisors Middleton, Idleman, Hogan, Clary, Rozell and adopted. Supervisors Fedler, Hicks opposed.

Mr. Shaw stated an amendment is needed to this resolution and asked the County Administrator to explain. He added that each Board member has a copy of the proposed amendment on their desks. Administrator DeBolt explained that at the Finance meeting, he was using estimates from NYSAC on what the DA's salary would be as of April 1, 2018. After the Finance meeting, he received an email from NYSAC with the actual calculation from the NYS Commission on Legislative, Judicial and Executive compensation indicating the salary should be \$197,000. The proposed amendment reflects amending the salary to the new amount and adjusts the budget amendment accordingly. A motion to amend Resolution No. 80 amending the District Attorney's salary to \$197,000 effective April 1, 2018 and increasing the amount of the budget amendment from \$9,600 to \$13,600, moved by Mr. Shaw, seconded by Supervisors Fedler, Moore, Campbell, Rozell and adopted. Supervisors Haff, Middleton opposed. Resolution No. 80, moved by Mr. Shaw, seconded by Supervisors Ferguson, Campbell, Moore, Fedler, Hogan, LaPointe, Rozell and adopted, as amended, by the following roll call vote:

CHAIRMAN HENKE stated that this just came up vesterday and he would have preferred to bring this through committee, explaining that the Board must pass this home rule resolution in order for the state legislature to consider changing our tax status. He received a call from Assemblyman Stec's office saying we needed to pass this right away and that is why he put this resolution forward. Mr. Shaw reminded all the Supervisors that this is related

to financing that we incurred. Chris DeBolt, Administrator stated that a few years ago, SUNY Adirondack came to us with plans for the new NSTEM building on their campus. We are a sponsor county for the college so when they do a capital project, we split the capital costs with Warren County based on the total assessed valuation between the two counties. After much discussion, both counties decided to go forward and we took out a BAN to cover our portion of the construction costs. When the numbers were run, it turns out that our debt service on the BAN equals almost identically what that additional quarter percent in mortgage tax would bring in and use on a community college is an allowable use under state law. The solution brought forward was to ask the state legislature for parity with the other upstate counties. Discussion ensued. Resolution No. 84, moved by Chairman Henke, seconded by Supervisors Fedler, Idleman, O'Brien, Campbell, Skellie and adopted by the following 2/3 roll call vote:

Resolution No. 88, moved by Mr. Shaw, seconded by Supervisors Fedler, Campbell, Rozell. CHAIRMAN HENKE asked for discussion. Mr. Shaw stated that not enough information was available at the Finance meeting to thoroughly vet this decision and asked the Administrator to answer any questions the Board may have. Mr. DeBolt stated this was an RFP for a potential three-year contract and the resolution in front of the Board awards to the lowest respondent. This represents a total savings of \$36,250 over three years compared to the proposal submitted by the County's current audit firm. This proposal includes travel costs and their references were checked out and the Treasurer was satisfied. Resolution No. 88, moved by Mr. Shaw, seconded by Supervisors Fedler, Campbell, Rozell and adopted.

CHAIRMAN HENKE asked for Supervisors' comments. Mrs. Fedler acknowledged that the Cambridge girls basketball team is playing in the state semi-finals today at 10:00 AM and wished them luck. She also acknowledged the loss of Dick O'Hearn who passed away, to the communities of Cambridge and White Creek. Ms. Idleman recognized George Bell and stated his death will be a huge loss to the community of Greenwich. She also recognized a Greenwich elementary student, Caroline Kelly, who participated in a pi contest and was able to recite pi to 500 numbers. CHAIRMAN HENKE noted the Board had a couple of votes on unfunded mandates today and if we want to vote against unfunded mandates, the Board has to go against the law of the land and puts legislatures such as ourselves in a very odious position.

Mr. Shaw announced the adjournment of the meeting at 10:48 AM.
