Support-Link assists individuals with disabilities in achieving their highest potential by connecting them to desired and necessary community supports. They offer Fiscal Intermediary Services including Compact Respite, SEMP, IVDS, OTPS, and Live in Care Giver services. Each person receiving services has funding attached to them. They also provide service coordination through OPWDD and through the nursing home transition waiver and TBI waiver. They provide counseling services, living skills training and environmental modifications and costs. They provide services to individuals in nine counties that include Warren, Washington, Essex, Clinton and Hamilton Counties. Their offices are located at 383 Bay Road, Queensbury. Carlson started the discussion stating there are 3 Care Coordination Organizations serving Warren and Washington Counties; Care Design NY, Tri County Care, and LIFEPlan. M. Beyer continued stating letters have gone out from the Central Office to the current MSC's to start to work on the enrollment and consent forms to CCO's with the individuals; This has to be done by June 30 th . NY START	J. Calandra and C. Hill overviewed and discussed the NY START Program. It is a community-based OPWDD program that offers crisis prevention and response services to individuals with intellectual/developmental disabilities and complex behavioral health needs as well as to their families and those who provide support. They emphasize the development of cross systems relationships, trainings and education, as well as crisis prevention and response supports. Its goals include helping individuals remain in their homes and communities, and enhancing their opportunities for leading healthy, successful and richer lives. Referrals are accepted from individuals, families, service providers (I/DD & mental health), hospitals, psychiatric centers and other crisis services for individuals age 6 and over who have an intellectual/developmental disability and complex behavioral health needs with an OPWDD eligibility determination. They are fully operational in Western New York, Finger Lakes, Capital District, Taconic and Hudson Valley regions.
