| <p><u>Agency/Program Presentations:</u> Northern Rivers/Parsons Mobile Crisis Services – Adrienne Slayko, LMHC</p> <p>NYAPRS (Hudson River Region) - Perryn Dutiger, Training and Technical Assistance Facilitator</p> | <p>A. Slayko started out by telling us the new Director for the ACT Team is scheduled to start July 30, and they will be co-located with Mobile Crisis.</p> <p>The Mobile Crisis phone number and hours have changed to 518-292-5499 Monday – Friday 8am-10pm and Saturday – Sunday 11am-7pm. Currently they are fully State Aid Supported and Grant operated working on becoming billable. Their ultimate goal is to be 24/7 next year. They are collaborating with NYSTART for trainings and law enforcement for wellness checks. M. McLaughlin form AHI Suggested collaboration with GFH for further expansion.</p> <p>P. Dutgier reviewed a PowerPoint presentation and provided a booklet outlining New York Association of Psychiatric Rehabilitation Services; collective recovery, rehabilitation, rights, promoting effective service design and delivery that advances people’s and program recovery outcomes. They offer trainings on site at no cost to OMH licensed or funded programs, CEU hours for Social Work, CPRP and CRCC, and Training Series such as Recovery, Cultural Competency I & II, Management, Practice and Employment. They also offer Technical Assistance such as PROS Implementation and Organizational Change. New trainings for 2018 include New Staff Orientations, Cultural Competency III, Developing Effective Staff through Teambuilding and Collaboration, Motivational Interviewing 101, and Healing through Mindfulness. | 2019 Local Services Planning Cycle | C. Wright provided a PowerPoint presentation and reviewed the nine outcome topic areas, the goals and objectives of the 2019 Local Services Plan that is due this month. The topic areas included are; Timely access to flexible, appropriate Behavioral Health supports and services; Expand access to housing options that are safe, affordable and person-centered, working with the local CoC to explore funding opportunities for permanent supportive housing; Expand alternative transportation ideas and options for individuals across all three disability areas; OCS will encourage local providers to collaborate and implement effective strategies to address workforce recruitment and retention shortage issues across all three disability regions; Advance a population health approach to clinical services; Support all initiatives through Medicaid Redesign, DSRIP and Managed Care HCBS waiver Services and develop culturally competent, person-centered, recovery-oriented services and culture; Expand substance use disorder services to align with local and regional needs; the North Country RPC will continue to address identified issues and challenges and recommend solutions directly related to Medicaid Redesign and the transition to Medicaid Managed Care, and the County Disaster Mental Health team for Warren and Washington Counties will be an appropriately staffed and trained disaster mental health resource in the event of the need for deployment. | N/A |
| <u>2018 – 2019 NYS Budget Update:</u> | R. York included the MHANYS 2018-19 budget update since the statewide association hasn't issued theirs yet. He outlined a few areas in the update such as Funding for SUD Treatment and Transition Services in County Jails, The OPWDD, OMH and OASAS Workforce Salary Increases of 3.25%, Health Homes, State Psychiatric Center Downsizing and Community Reinvestment of \$110,000 for every bed closed, Children's Behavioral Health Services, OMH Supported Housing, Medicaid Pharmacy Prescriber Prevalence rejected, Telehealth, \$1.5M for Independent SUD and Mental Health Ombudsman, Certified Peer Recovery Advocate Services Program, \$100K North Country Behavioral Healthcare Network for Suicide Prevention Funding to Council for Prevention, \$3.74M Joseph P. Dwyer Veteran Peer to Peer Services which is \$185K for Warren & Washington Counties, CLMHD got \$3.75 million to provide funding for Counties to contract or develop jail based substance abuse and treatment services onsite or in the jails. | N/A |

York outlined a report HCBS Access Data by County Fiscal Responsibility stating there aren't enough providers and as of March 22, 2018 Warren County has only 3 people receiving HCBS Services out of the 430 HARP eligible.</p> <p>R. York discussed the RPC identified top 3 issues and challenges related to Medicaid Redesign and the transition to Medicaid Managed Care; Regulatory Issues regarding Housing, Integration of PC and BH and Telemedicine, Children and Families Issues, Workforce Issues and recently added Rural Transportation Issues. OMH, OASAS, OPWDD and DOH have regular meetings to discuss these issues and challenges.</p> | N/A |
| <p>Hometown vs. Heroin and Addiction update</p> | <p>S. McManus reminded us that there are monthly meetings the second Tuesday at 3:30pm at the Council for Prevention. They are focused on Neonatal and Substance Use with monthly meetings on Friday at 7:30pm. They are planning for a Resource Fair for Recovery Month on September 21, 2018 with a set up at The Queensbury and a 5K walk/run around Glens Falls.</p> | N/A |
| <p>Informational Items: Sequential Intercept Mapping (SIM) follow-up</p> <p>SA Residential Services</p> <p>Molly Cochran- McConnell Memorial Fund</p> | <p>C. Wright and C. Green have been meeting with key people to get provider and law enforcement groups together to discuss SIM objectives and schedule another CIT training. More to come.</p> <p>R. York discussed the closing of 820 River St. at their Granville location. They had a 60-day plan for appropriate relocation of 12 women. Several were able to step-down to lower levels of housing support, and the rest went to facilities offering comparable levels of care. ACCA is in the process of purchase and renovation of a local property. K. Stack will be presenting in our October meeting to provide us with further information.</p> <p>R. York reviewed the Molly Cochran- McConnell Memorial Fund that provides scholarships for youth to go to summer camp. The application/selection process is managed by the Glens Falls Hospital Family Support program. They are trying to get CM into Irongate Family Practice. They are trying to get a Housing 2.0 model like housing first in Glens Falls. Maple St. Apartments is getting an elevator. July 1st WWAMH is Smoke Free and October 1st the residences will also be Smoke Free.</p> | |
| <p>Glens Falls Hospital</p> | <p>R. Wolfield told us staffing is still an issue. As of June 11th Social Workers are on board however they are still missing a secretary until July 30th. They did well keeping all programs and will add new groups such as Tobacco Cessation. Cambridge still needs someone 1 day a week as well.</p> | |
